The NAM, along with our partners and allies across the country, have launched a coordinated effort to secure rational liability safe harbors in the next COVID-19 relief bill from Congress, consistent with our [policy recommendations](#). The NAM has equipped our partners with tools to facilitate and track outreach to lawmakers, as we build on last week's [call to action](#) from 289 associations. As the Senate Judiciary Committee prepares to debate the value and form of liability protections in a hearing tomorrow afternoon, we are working to educate members of the committee and their staffs about the importance of providing certainty for manufacturers that are striving to do the right thing. ### **FEMA to Hold Online Pandemic Response Meeting**

Consistent with the NAM's recommendations, FEMA will soon announce a "Meeting to Develop Pandemic Response" to coordinate the efforts of critical medical resource manufacturers and distributors. The web conference is scheduled for Thursday, May 21, at 2:00 p.m. EDT, and we expect FEMA will open registration this week. We will share that registration when it is available, and we encourage producers of critical medical supplies to register and participate.

### **Call to Action for Manufacturers of Medical Supplies**

At the request of the White House and senior administration leaders, manufacturers of critical personal protective equipment and medical supplies will receive a "call to action" for information on next-level engagement and capacity expansion. This call will be delivered to those firms that have produced PPE and medical supplies as well as those that have previously responded to NAM surveys.
